### FIRE REGULATIONS:

1. Drapes must be fire retardant
2. Appliances must have heavy duty cords.
3. Do not block Fire Extinguishers or Fire Lanes

### GENERAL RULES:

1. Every class offered herein will be shown and judged according to Pinto Horse Assoc. Inc. rules. A copy of the rule book is in the Show Office, and with the Show Committee members. All exhibitors must be current members of P+HA. All horses, ponies, and miniature horses must be registered with P+HA and all owners must be current members of P+HA.
2. Knowing the rules and regulations as well as the requirements of each class entered is the exhibitors' responsibility.
3. Having the correct back number at the time you enter the arena for the purpose of a class is the responsibility of the exhibitor.
4. Persons under the age of 18 may NOT exhibit stallions.
5. To be eligible for P+HAWW year end points and awards all indebtedness must be paid. P+HAWW will charge a \$30.00 fee for all NSF's checks.
6. Entries received after the posted pre-entry due date are subject to a post entry fee of \$20.00. NO POST DATED CHECKS WILL BE ALLOWED. MAKE CHECKS/MONEY ORDERS PAYABLE TO P+HAWW.
7. Entries will be accepted until 3 classes before the class enters the gate. Entries for the first 4 classes of the day will be accepted until 7:00 AM Friday, Saturday and Sunday. All post entries will be at the stated fees. All entries must be cleared through the Show Office before you enter the class. You may enter at the gate, however, you must go to the office and complete an add/drop sheet immediately following your class.
8. NO entries will be refunded without a Veterinarian's certificate. This must be presented to the show secretary before the first class in which the entry is to be shown. At the show a Veterinarian's certificate may be waived at the discretion of the show management/show committee staff
9. The Show Management Committee reserves the right to cancel and combine classes that do not fill or that do not have enough entries. Classes may be run (with Show Management Committee prior approval) with less than 3 horses for the purpose of earning show points only. Entry fees are refunded if a class is canceled. **SATURDAY HALTER CLASSES WILL BE COMBINED FRIDAY EVENING. The Show Management Committee makes the decision to cancel or combine a class; they must not change that class, even if late entries change the status (P+HA Rule F1-F).**
10. Any discourtesy to a judge or show official on the part of an owner or exhibitor shall disqualify an entry and all entry fees paid shall be forfeited.
11. All Miniature Horses and Ponies without a valid measurement card must be measured prior to exhibiting.
12. Gate Holds must be requested to the in-gate or show office personnel, no later than 2 classes prior to the needed gate hold.
13. No persons shall approach the Judge (s) with regard to a decision until they have obtained permission from the Show Management Committee who will arrange appointment between the various parties.
14. **THE JUDGE'S DECISION IS FINAL IN ALL CLASSES**
15. Unattended horses are not allowed at any time in the aisles or anywhere on the grounds except when they are in stalls. Infractions may result in the removal of animals and exhibitors from the grounds.
16. A health certificate is required for all horses, ponies, and minis' transported into the State of Washington.
17. Refund checks will only be given after the exhibitor's check has cleared our bank (4-6 weeks). There will be NO cash refunds.
18. **TACOMA UNIT Rules:**
  - a. ALL DOGS MUST BE ON A LEASH, TIED OR CONFINED AT ALL TIMES. THERE IS A LEASH LAW IN PIERCE COUNTY AND IT MUST BE ADHERED TO.
  - b. NO ALCOHOL ALLOWED ON SHOW GROUND.
19. No class can be added or split. P+HA rule for 2007.
20. YA Lead line entrants must be age 8 or under. Lead line entrants may not cross enter into YA Walk/Trot Riding Classes or any class that requires jog, trot, canter or lope.
21. Once the gate is closed, class has been run, judges cards signed and turned in, the class is considered complete (P+HA Rule F.C.6)
22. R.V. pass is required if you are hooked up at anytime to electrical outlet.
23. There will be NO guaranties of holding any stalls without appropriate fees paid in advance.
24. **YOUTH AND AMATUER MINI AND PONY SHOWMANSHIP CLASSES MAY NOT CROSS ENTER INTO HORSE SHOWMANSHIP CLASSES, UNLESS THEY ARE COMBINED BY THE SHOW MANAGEMENT COMMITTEE DUE TO A LACK OF ENTERANTS. IF THE CLASSES ARE COMBINED, THE AMATUER AND YOUTH ENTERANTS WILL COMBINE WITH THEIR AGE GROUPS FOR THE APPROPRIATE SHOWMANSHIP CLASS.**
25. **TACOMA UNIT CHARGES \$50 PER DAY STORAGE FEE FOR ANY CAMPER, MOTOR HOME OR HORSE TRAILER THAT IS ON THE GROUNDS BEFORE THURSDAY AT 12:00 NOON AND MONDAY MORNING AFTER THE SHOW. THIS FEE IS CHARGED NO MATTER IF THE VEHICLE IS HOOKED TO POWER OR NOT. IF YOU NEED TO DROP OFF YOUR VEHICLE BEFORE THURSDAY OR LEAVE IT AFTER SUNDAY NIGHT, IT IS YOUR RESPONSIBILITY TO MAKE ARRANGEMENTS WITH PAULETTE. YOU WILL ALSO BE RESPONSIBLE FOR PAYING THE \$50.00 PER DAY STORAGE FEE THAT THE TACOMA UNIT CHARGES. THESE CHARGES ARE TO BE PAID DIRECTLY TO THE UNIT AND NOT TO P+HAWW.**
26. **ANY NSF CHECKS ARE SUBJECT TO A \$50 FEE AND MAY ALSO RESULT IN THE EXHIBITOR BEING ON A CASH OR MONEY ORDER ONLY BASIS FOR THE DURATION OF THE SHOW SEASON YEAR. ALL NSF FEES MUST BE PAID BY NOVEMBER 30 OF THE CURRENT YEAR OR THE EXHIBITOR WILL BE DEEMED INELIGIBLE FOR YEAR END AWARD PRIZES. ALSO THE PINTO HORSE ASSOCIATION OF WESTERN WASHINGTON RESERVES THE RIGHT TO SUBMIT THE NAMES OF MEMBERS TO PINTO FOR FURTHER DISCIPLINARY ACTION TO BE TAKEN, PER PINTO RULE.**
